Website Terms & Conditions

This Website Terms & Conditions ("T&C") is a legally binding agreement made by and between The Mission and you, and it governs the Mission website and all the websites associated with The Mission.

The Mission websites are maintained by The Mission, with headquarters at PO Box 360 Portraro, CA, 91963 U.S. telephone (619) 661-9232.

By visiting any of The Mission websites, you agree to be bound by this T&C. If you do not agree to be bound by the T&C, do not access or use The Mission websites or the advocate program. By accessing or using any part of The Mission websites or by registering for or using any The Mission service, including, without limitation, by joining the Advocacy program, you agree that you have read, understand, and agree to this T&C.

Changes to this T&C and the Mission Websites

Changing business practices and circumstances may require that we make changes to this T&C and to The Mission websites. The Mission reserves the right to modify its websites, and/or this T&C at any time. Any changes will be reflected on The Mission websites and revision shall be effective immediately on such posting, and you are deemed to be apprised of and bound by any such modifications. You agree to review this T&C and other posted online policies periodically to be aware of any revisions.

Your edits or changes to either online or offline versions of this T&C will not be effective, regardless of form.

Eligibility

Authorized Use

As an Advocate, we give you permission to access and use The Mission websites for your personal use for the purposes for which is intended- to copy, distribute, and transmit the content of the websites only to the extent that such copying, distribution, and transmission is automatically done through your browser software. This includes using the websites for your personal use, or as expressly permitted by The Mission (for example, if The Mission provides a method for you to post information to your Facebook page). You may download or electronically copy and print a copy of the information displayed on The Mission websites for your personal use and no rights to those materials are transferred to you by such copying.

Unauthorized Use

The goal of The Mission websites are to raise awareness of and raise funds for The Mission. Intellectual Property and Content

Intellectual Property Rights

The Mission websites, names, trademarks, logos, designs, text and graphics used on The Mission websites, the selection and arrangement thereof, and all other materials used on these websites, are and shall remain owned or licensed by The Mission. Notwithstanding the foregoing, from time to time, certain third party trademarks, copyrighted materials and other intellectual property not owned by The Mission may appear on these websites, for example, when someone posts a picture to the Advocate program website. When such materials appear, appropriate credits and notices may be displayed. We will retain ownership of our intellectual property rights and you will not obtain any rights therein by virtue of this T&C or otherwise.

Indemnification

If you are obligated to provide indemnification pursuant to this provision, we may, in our sole and absolute discretion, control the disposition of the claim, demand, or action at your sole cost and expense. Term; Termination; Survival

For purposes of clarity, the survival of the provision on Unauthorized Use means that even if your account is terminated, if you breached the Unauthorized Use provision while using The Mission websites, we have the right to sue you for damages or injunctive relief.
